


# Group Legal Service Plan



## **Description of Plan**

Kohler Credit Union has contracted with the law firm of **Olsen, Kloet, Gunderson & Conway** to provide legal advice and consultation to credit union members. Advice must be through an in-person conference at the offices of the law firm, or at a mutually agreeable location.

This plan is not a substitute for the retention of your own personal attorney. It is the intent of this plan to encourage the obtaining of legal advice and consultation when for reasons of anticipated expense you would not otherwise do so.

You are not required to utilize the services of the retained law firm, either for advice, consultation, or for other services. You are free to utilize any attorney of your choosing.

IF YOU RETAIN THE FIRM FOR LEGAL SERVICES BEYOND ADVICE AND CONSULTATION, YOU SHALL BE RESPONSIBLE FOR THE COST OF SUCH SERVICE.

If a question arises involving two credit union members and/or a conflict arises, advice and consultation shall be provided at the retained law firm's discretion.

## **Special Exceptions**

- 1.Disputes between members of Kohler Credit Union and clients represented by the retained law firm; and
- 2.Matters directly involving the sponsor credit union.

#### **Consultation Services Available**

Services relating to most legal matters including personal injury, worker's compensation, family law, landlord/tenant law, real estate, creditor/debtor rights, business law and organizations, civil litigation, traffic law, consumer law, and consumer rights.

Subjects not covered include, but are not limited to: bankruptcy, patent, trademark and copyright, criminal law, securities, and anti-trust law. However, appropriate referrals for such areas can be provided, upon request.

#### **Limitations on Services**

Preparation of documents (work product) such as agreements, deeds, tax returns, letters or legal process, and representation and negotiations or court appearances are not funded under the plan.

After completion of advice and consultation, if it is determined that additional legal services are required, the member may retain the services of Olsen, Kloet, Gunderson & Conway to proceed in the matter or retain the services of any other attorney.

Any member shall not be entitled to receive more than two (2) consultations of up to one-half hour each in any one year, on two unrelated matters per year. "Member" for this limitation means any member of the Kohler Credit Union in good standing.

The above limitations shall not be cumulative regardless of the number of plans to which the member may belong.

### **Procedures in Utilizing the Plan**

- 1. Place a call to the retained law firm in Sheboygan at (920) 458-3701, or send an email requesting same to mail@olsenkloetlaw.com. Office hours for telephonic inquiries are Monday through Friday, 8:00 a.m. to 5:00 p.m.
- 2.Please provide your name and credit union account number.
- 3. State the nature of your problem to the secretary of the law firm answering the call, who will set an appointment with an attorney.
- 4. At the appointment, the attorney will respond to your question and render a legal opinion to you.
- 5. If further legal services are recommended, the attorney will advise you to seek the services of your own personal attorney, or provide you with the opportunity to utilize the services of the retained law firm.
- 6. If you desire to proceed with further legal services, you may contact your personal attorney or retain the services of the advising attorney provided by the credit union.

#### **General Provisions**

- 1. Eligibility shall be limited to those Kohler Credit Union members in good standing.
- 2. The credit union shall not be liable to the member or any other person or persons regarding any act or omission of the retained attorneys.
- 3. The attorneys retained shall exercise independent professional judgment and shall not engage in any misconduct or unethical behavior as defined by the rules governing the discipline of attorneys.
- 4. This plan may be terminated by the sponsor at any time.
- 5. The sponsor and any and all persons and/or entities connected with it shall not derive directly or indirectly any profit from the rendering of legal services pursuant to this plan.
- 6. This plan is subject to the administrative and professional regulation of the State Bar of Wisconsin.
- 7. Questions concerning services or fees which cannot be resolved between the credit union member and the law firm shall be submitted to arbitration pursuant to Wisconsin Arbitration Law and all parties shall be bound by the decision of the arbitrators.
